Off Season Board Meetings:

 Board Meetings October-December on Tuesdays will be at 9:00 a.m. and will be held at Kelly King's house.

Announce the Following Winners at the Year-End Banquet:

- **Eclectic Gross** (\$138.00 check)
- **Eclectic Net** (1st place \$92.00 check; 2nd place \$45.00 check)
 - These winners are given a check. Money is from part of the Club dues paid annually.
 - Kelly King has the checkbook to write these checks in Rhonda's absence.
 - Dan sent a report and we need to figure out how we are going to payout for Net since we pay-out 2 places but have 3 flights.
- Currently we have 24 **Birdie** Pins to hand out. We are short 4 pins and Judy purchased 12 additional pins.
 - While this person will not get a gift, the Winner of Most Birdies will be recognized at the Year-End Banquet.
- On 10/12, I asked Kristian if they could run reports for the following categories: BROKE 100 (we have only 3 of these pins on hand), BROKE 90, BROKE 80. Right now, we know that both Debbie Knapp and Jodi Davis eligible for BROKE 100. I also sent Dan an email 10/13 requesting the Broke, Most Improved and President's Cup Gross Winners names.
- Most Improved Players by Flight: No gift/award; however, we want to acknowledge these ladies for their accomplishments.
- **President's Cup** Judy has asked Kristian to provide the Gross Winners for each of the three flights for the President's Cup. Our Rules state that winners for the President's Cup are in both gross and net categories and we only acknowledged net. We may need to re-distribute the funds for this tournament to include the gross winners.

Luncheon:

- Jodi is providing the taco bar, salad and gorgeous cupcakes for dessert (both chocolate and lemon/raspberry). Jodi will submit an invoice to the club for \$400.00 for the taco bar.
- Our income will be approximately \$150.00 (\$5.00/person X 30).
- Kelly & Judy will purchase the following items for the luncheon: Beverages (White Claws, water, white wine, and Judy will provide 3 bottles of red wine), appetizers (chips, salsa and guacamole), and forks.
- Paper goods: Jodi has cups, plates, and napkins.
- Helium Tank—Judy ordered a helium tank online and it is being sent directly to Jodi's house. She has all the decorations, including balloons.
- On the day of the event both Jan and Kelly will be at Jodi's house early to help her with set-up. Also, Lani and Sarah may be available to assist.

Chipping Contest:

- We decided to not do both a chipping and putting contest and will only hold a chipping contest.
- Jodi is **not** going to be involved in these contests so it will be up to Club members to run this! We need to recruit a couple of members to assist in the competition. Judy sent an email to Suze and Patti.
- We will give out 4 place "awards" for the chipping contest and Judy has the gifts already for that which you saw at the Board Meeting.
- I think Dan has some round markers he's used for tournaments before and I'll ask him if we can use them for our competition.

Rules for Chipping Contest:

- Use the foot golf tub that is located right by Jodi's house.
- Jodi has a chipping mat that will be set up on her patio.
- Players will hit from the mat to the foot golf tub.
- Three balls to hit the target. 2 Points if the ball lands inside the foot golf tub. 1 Point if the ball lands and stays within 10" of target circle. No points for balls landing/staying any further away than 10" of the target circle. Most points wins (1st, 2nd, 3rd and 4th place winners).
- If Ball #2 or #3 moves a ball within the circle to outside the circle, that previous ball maintains the points it earned when you initially hit it.
- If you hit Ball #2 or #3 and it moves a ball outside the circle into the circle, that ball that moved by being hit by another ball does not get any points.
