**Local Course Rules:** Patti Parker led discussion and explained the proposed rules.

Controversy ensued especially about playing from waste areas and bare ground patches and what constitutes abnormal conditions. Joni Taylor said that USGA does not penalize for moving ball out of waste area. Given the many 'rough' and abnormal conditions on our course, she suggested that more consideration should be given and decided by consensus within individual foursomes the relief a player should take.

Joni also brought up that Net Double Bogey should not be applied in Tournament Play and said player should be disqualified if they don't finish a hole.

**ACTION ITEM:** The above topics and others regarding Rules will be taken up at Board meeting on May 6 and brought back to the membership for approval.

When in doubt — Suze reminded us about taking pictures and bringing them into Dan for official ruling.

**Pace of Play:** Anne Henderson said the Senior Women's Group provides clearly stated rules about adhering to play etiquette, particularly pace of play.
